The acquisition of the shares was carried out by a bank commissioned by Beiersdorf Aktiengesellschaft.

The 2024 share buyback program was thus successfully completed on 06 August 2024. Treasury shares were acquired at a total price of around EUR 499,999,910.97 (excluding incidental acquisition costs). The maximum purchase volume of the 2024 share buyback program of up to EUR 500 million was therefore almost completely exhausted.

The total number of shares acquired under the share buyback program in the period from 24 April 2024 up to and including 06 August 2024 amounts to 3,604,604 shares. This corresponds to around 1.45% of the company's share capital. The average purchase price per share was around EUR 138.7115.
